The grant covering social security expenses may not exceed 1,200€ per worker recruited either full-time or part-time, with an aggregate yearly maximum of 4,000€ per company (minimum corporate longevity 12 months).

B) Business sector	Grant maximum amount: 40% of the external service expenses, with a maximum of 500€ per project

COMPETITIVENESS PROMOTION SCHEME SUBSIDIES FOR RETAILERS IN VANDELLÒS I L'HOSPITALET DE L'INFANT.

Concept	Subsidy amount
a. Upgrading signs and external image (façade) of retail premises. Promoting a modern, clean, and upgraded commercial image perception.	a) Upgrading signs and external image (façade) of retail premises. Total subsidised amount of 30% of expenses (excluding VAT) substantiated by provider's invoice, with a max. amount of 400€ per retailer
b. Upgrading the retail premises' lighting. Promoting new energy efficiency measures.	b) Upgrading the retail premises' lighting. Assessment and fare adaptation with 100€ per project.
c. Implementing effective window-dressing measures. Promoting the continuous upgrading of retailers, improving the collective perception of purchase freedom, and encouraging presentation in self-service format.	c) Implementing effective window-dressing measures. Attending fairs, contracting external tailored window-dressing services. Total subsidised amount of 40% of expenses (excluding VAT) substantiated by provider's invoice, with a max. of 200€
d. Promoting actions aimed at minimising the visual impact of closed commercial property and favouring their transformation into retail premises	d) Promoting actions aimed at minimising the visual impact of closed property and favouring their transformation into retail premises. Grant covering up to 75% of property tax (IBI) – according to property size in sqm, in 4 years thereafter for achieving that an empty property located in a commercial priority area is transformed into retail premises. Grant covering 50% of property tax in 4 years thereafter for maintaining closed property in decent conditions favouring decor and positive appearance.
The maximum subsidised amount of substantiated expenses excluding VAT may not exceed 1,000€ for the whole set of actions per retailer.
